Conditions for Winners Members

The Sports Council for Wales owns and manages the Welsh Institute of Sport (the "Institute"). The Institute strives to maintain a full programme and use of facilities at all advertised times. However, due to other bookings or circumstances beyond our control this may not always be possible. If facilities are known to be unavailable then these will be advertised in advance.

- The decision to accept the application of a new member shall be at the sole discretion of the Institute. The Institute reserves the right to verify or require proof of all information given in order to obtain membership. The acceptance by the Institute of an application for membership shall constitute a legally binding agreement between the member and the Institute. The member hereby agrees to be bound by the laws and regulations of the Institute and by these Conditions.
- Subject to condition 1, full membership is valid for one (1) year (temporary membership one (1) month) from the date of signing of this agreement, and is the property of the Institute.
- A valid membership card must be produced at reception on each and every visit before using any facility and/or service. The Institute retains the right to refuse entry or request an entry fee if a valid membership card is not shown. Membership of the Institute and membership cards are non-transferrable and may only be used by the registered member. Lost or damaged membership cards will be subject to a replacement charge.
- All members wishing to use the cardiovascular (CV) or free weights rooms will be required to complete a weights induction course and a health questionnaire before using these areas.

Limitations of Liability

The Institute does not seek to limit liability for death and/or personal injury arising from negligent conduct of the Institute or its employees.

The member acknowledges that they are responsible for the use of the facilities at the Institute. The safekeeping of all personal items is the sole responsibility of the owner/keeper. The Institute will not be liable for any direct or indirect or consequential loss including, without limitation, loss of revenue, loss of profits, loss of business, contracts or goodwill arising under contract, tort (including negligence) or otherwise.

Subject to conditions 5 and 6, the member agrees that the Institute's total liability arising out of this agreement and the member's use of the facilities, in the event that any limitation or provision in these conditions are held to be invalid, shall be limited to one hundred pounds (£100.00)

Cancellation

Members will be required to pay in full for any cancelled facilities which are not resold or for any failure to attend and use a pre-booked facility.

Membership Rules

- Dogs, except for assistance dogs, will not be admitted.
- No food is to be consumed in any of the activity areas. Drinks may only be consumed from plastic sealable drinking bottles in activity areas and glass bottles or cans shall not be taken into any activity area.
- Appropriate fitness clothing must be worn at all times. Soiled clothes/footwear will not be permitted. Appropriate footwear must be worn at all times. Black-soled shoes (or marking shoes) must not be worn in any sports hall, squash court or activity area.
- Kit bags must not be taken into the weight training room. Lockers are provided in all changing rooms and customers are advised to use them at all times. The Institute will not accept responsibility for any personal property left in changing rooms or in lockers. The Institute advises members not to bring items of significant value to the premises.
- The Institute provides free car parking to members when using the Institute (subject to availability). Where the member parks their car on the Institute's premises, it is at the member's sole risk. The Institute does not accept liability for any loss or damage to the member's car unless the loss or damage is caused by an act or omission of the Institute.
- No alcohol, other than that purchased at the facility, is permitted to be consumed on the premises. Anyone considered to be under the influence of illegal drugs or alcohol shall be omitted from the facility.
- The Institute reserves the right to restrict admission and/or evict members who do not comply with these conditions or misconduct themselves or cause danger or annoyance to others. In such circumstances the Institute may cancel membership without refund.
- At the end of any membership period, members will be given up to 14 days to renew their membership. After 14 days, membership will have lapsed, and any initial joining fee may become payable.
- Full adult members who undergo a change of circumstances (e.g. becoming unemployed or a Senior Citizen) may be entitled to reduced rates when using the facilities on evidence of such change. Such entitlement shall not arise until subsequent renewal of membership.
- The Institute reserves the right to withdraw the use of any facility at its sole discretion. Any deposit will be refunded, but the Institute accepts no liability for any other expenditure incurred or loss sustained as a result of withdrawal.
- Cancellation or refund of any membership fee is strictly at the discretion of the Institute.
- The facilities will not be available during the Christmas period and public holidays except in exceptional circumstances. Please enquire at reception and check notice boards for further information.
- The Institute reserves the right to waive all or any of these conditions.
